Enroll & Register

Before you enroll in the CFA Program and register for your first exam:

1. Meet the entrance requirements:

- **Have a bachelor's (or equivalent) degree**
 - or be in the final year of your bachelor's degree program at the time of registration*
 - or have four years of professional work experience (does **not** have to be investment related)
 - or have a combination of professional work and college experience that totals at least four years. Part-time positions do not qualify, and the four-year total must be accrued prior to enrollment.
- **Understand the professional conduct requirements** (you will be asked to sign the [Professional Conduct Statement](#) and [Candidate Responsibility Statement](#))
- Be prepared to **take the exams in English.**
- **Effective 1 January 2011:** Have a valid international travel passport (required for enrollment and exam registration). [Read the ID policy.](#)
- **Note:** Residents of certain countries may be prohibited by law from participating. Read the [OFAC Compliance Policy.](#)

2. **Decide when to take your exam;** [check the exam calendar](#) and review the fees and deadlines.

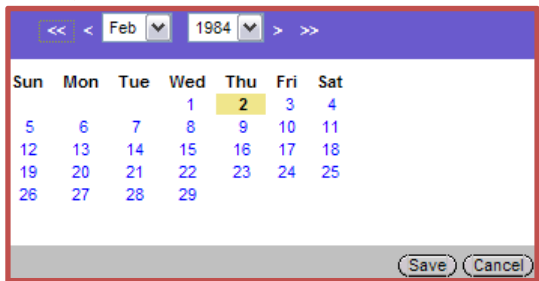

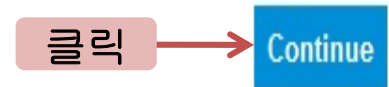
